AMENDMENT TO VIGILANCE CLEARANCE POLICY

There have been grievances of undue hardship created in certain specific cases because of the vigilance clearance policy enunciated vide memorandum number VIG/10(7)/2013/1128 dated 30 April 2013. The grievances have been examined.

After careful examination, it has been decided to partially amend the policy as follows:-

1. In the case of application for outside employment, denial of vigilance clearance will be considered only for cases where such application without intimation was made on or after 30 April 2013. That is, if an employee applied for outside employment without intimation before 30 April 2013, then it will not be considered for denial of vigilance clearance.
2. In case of an employee overstaying more than one year beyond tenure as envisaged in CVO GRSE OM dated 27/2/2012, the concerned GM/CGM (or AGM in-charge in absence of GM/CGM) responsible for recommending his transfer will also be denied vigilance clearance for the same purposes as the one overstaying tenure in sensitive post. However, this will come into effect from 1 January 2014.
3. Regarding missing deadline for submission of Annual Property Return as on 1 January 2013, as a special case vigilance clearance will not be denied if the concerned officer/supervisor submits the property return within 25 June 2013. This is a special case considering a large number of defaults, and this will not be cited as precedence.
4. On transaction in movable/immovable property, "mandatory prior intimation/sanction" shall be replaced by "prior or later intimation/sanction as per the applicable rules."
